#### Qualitative analysis of Criterion 1

Govt. College, Meham is a co-education college which owns 25.3 acres of land with a built up area of 6272 *square meters*. It is affiliated to the Maharshi Dayanand University. The Curriculum as designed by the University is implemented by the college. The methodology of implementation of curriculum comprises written test, assignments, presentations, field visits etc. College prepares the academic time-table and follows it assiduously. Teachers are responsible for the teaching plan as recommended by the university. Cultural, co-curricular and extra-curricular activities are planned at the very beginning of the Semester. IQAC cell exists in the college which ensures that academic standards and quality are maintained by conducting academic audit periodically. The curriculum is periodically revised/upgraded by the affiliating university. College sensitizes the students regularly about the contemporary issues such as gender parity, climate change, Human values, Eco-concerns, Ethical and Moral values. College conducts programmes to create awareness among the students and the society pertaining to Environment and Sustenance and also to address the issues associated with the problems of rural areas. The majority of the students undertake field work /project work / internships. The feedback mechanism has been introduced by the college but needs further structuring. The institution has already applied for the PG Courses under PM-USHA Central Govt. scheme.

#### Qualitative analysis of Criterion 2

Admission process in the college is executed as per the policy of the government and seats are offered to students from the diverse backgrounds. The Affiliating University prepares a Calendar of Events in the very beginning of the academic year and the same is communicated to the college. Consequently, the college is bound to adhere to the schedule as shown in the calendar of events. All the cells and committees in the college prepare their action plan for a semester and the same is reflected in the calendar of events. The college has provided the link of the affiliating university for the Program Specific outcomes and Course outcomes for all programs offered by the university. The same is communicated through an online platform and also through the website of the college. The faculty members encourage, motivate and support the students to develop their skills. The college conducts internal evaluation of learners to assess the capability of learning and grasping of the learner. Students are assigned 'seminars', 'group discussion', 'quizzes' and 'paper presentation' to measure the grasping level of the learners. Students are also encouraged to use the library independently and intensively that enhances their knowledge. The faculty prepares a statement of results and the same is hosted on the website. The program outcomes, program specific outcomes and course outcomes are analysed. The student-full time teacher ratio of the college is around 43: 1. A significant number of teachers in the college are Ph.D./NET holders .The average pass percentage of students during the last five years is 50 approximately. Based on the feedback from students it is apparent that a large majority of them are quite satisfied. Students centre methods of teaching learning are adopted to the possible extent Programme outcome and course outcome are communicated to students. Some faculty members developed e-contents and uploaded on You-Tube. College has a distance education of the Maharshi Dayanand University Rohtak.

A faculty member received a Gold Medal in National Yoga Championship.

#### Qualitative analysis of Criterion 4

The college is located in the historical place of Meham city and owns 25.3 acres of land with a built up area of 6272 *square meters*. At present, there are 25 class rooms (including 3 smart class rooms), 11 laboratories and one auditorium cum multipurpose hall with good audio-visual facility and seating capacity of 1000 persons. The college has also girls' common room, departmental rooms and separate washroom facility for boys and girls. The college has two computer labs having 50 computers and 1 language lab having 25 computers. The student-computer ratio is almost 26: 1. The college has a fully automated library with SOUL 3.0 Software having more than 21,000 books on different disciplines. The college subscribes huge number of e-books and e-journals through National Library and Information Services Infrastructure for Scholarly content (NLIST) of INFLIBNET. Both the teachers and the students avail the remote access to all the e-resources under NLIST. The entire campus is monitored by CCTV. The college has adequate facility for indoor and outdoor games. The expenditure incurred on maintenance of infrastructure excluding salary during the last five years is about Rs. 68.29 lakhs. The institution has already applied for up gradation of infrastructure likes smart class rooms and new software's under PM-USHA Central Govt. scheme.

The average percentage of students benefited by scholarships and free ships provided by the Government and Non-Government agencies during the last five years is 74.48. A transparent mechanism is present in the college for timely redressal of student grievances. The average percentage of placement of outgoing students and students progressing to higher education during the last five years is not significant. The number of awards won by the students for outstanding performance in sports 3 Gold, 3 Silver and 2 Bronze medal in the National Levels, cultural activities at inter-university / state level during the last five years is 12. College has registered alumni association which is active. Different cells like Legal Literacy, Women Cell, Yoga Club, Red Ribben Club and Counseling Cell are functioning.

#### Qualitative analysis of Criterion 6

Principal is providing good leadership and built a young team to work. In order to bring out the best out of each student in academics, cultural, sports and other co-curricular and extra-curricular activities, the college organizes various suitable programs. The college practises participative management on the campus. The office has maintained relevant documents pertaining to infrastructure and academic planning. The office of the Principal and the Heads of Departments meet very often to discuss the needs of the college. The help and support of financial nature to the teaching and non-teaching staff is provided and necessary administrative support is also available to the faculty. No teaching staff has been provided with financial support to attend a conference /workshop during the assessment period. Around 16 per cent teaching and non-teaching staff of the college have participated in faculty development programmes, professional development / administrative training programmes during the last five years. It is observed that the administration has created a very congenial and harmonious atmosphere for the faculty and staff. As far as financial aspects of governance are concerned, there is a provision for both internal and external audits on deposits, withdrawals and payments by

or to the college. The external audit is done by the audit team of the Accountant General of Haryana and the Higher Education Department of the Government of Haryana. The college is funded by the Haryana Government's Higher Education Department. The IQAC is in place headed by a faculty. Since its inception IQAC has been quite active. Many learner oriented activities have been planned and implemented during the last five years. The IQAC Coordinator with the help of the IQAC team assesses and analyses the course and programme outcomes and also reviews the performance of students and teachers and gives the feedback for improvement and quality enhancement. The IQAC conducts academic and administrative audit regularly. In order to enhance the knowledge base of the learners, special lectures are organized by inviting/engaging resource persons from outside.

#### Qualitative analysis of Criterion 7

All the members (teaching as well as non-teaching) and the students of the college engage themselves in carrying out different activities for maintaining institutional values and social responsibilities. The college is very active in adopting gender equity promotion initiatives during the last five years. The college conducts activities and events to sensitize students about gender equity. Thus far, no case has been reported of Sexual Harassment, Physical Abuse or Eve Teasing on the premises of the college. The CCTVs have been installed at strategic locations and are operational. A separate common room for girls sans amenities present. The college has a counseling cell that offers to diagnose the problems of women and extends help to them in every possible way. The college has taken suitable measures to maintain the practices of the management of solid waste, liquid waste and e-waste. The college has also adopted some measures to maintain the practice of water conservation as well as green practices. There are 4 rain water harvesting facility on the campus. The college has taken several initiatives during the assessment period for the betterment of the student community as well as the entire society, such as digital literacy workshops, mental well-being workshops, 'earn while you learn' scheme etc. The college celebrates Days of National Importance like Independence Day and Republic day with fervour and festivity. Birth and Death anniversaries of great personalities, important Days of National and International events are also celebrated meaningfully. Numerous initiatives have been taken by the NSS unit of the college to engage with and contribute to local community during the last five years. Circulars / Notifications related to university or department are put on notice board and are hoisted on its social
